The charity was set up by parents of severely autistic children in 1990, to help them and others cope with the challenges of autism in the family. They ran a very part-time helpline to offer information, support and a listening ear. They organised social activities to reduce some of the isolation from mainstream society. They ran events and fundraising activities to raise funds and spread the awareness of autism to the public. All this they did on a voluntary basis, while also looking after their families and fighting for their children's rights.

All of the original work of BAS continues today. In addition, we also lobby authorities, professionals and service providers for improved services and access to services and skills. We now have over 500 members, an office in Reading and employ several part-time staff to run our expanded programmes. These include parental support groups, social groups for adults with Asperger's, training courses for professionals and speaker meetings open to all. We still need to fundraise every penny of our income, every year, year after year.

**The incidence of autism has grown hugely over the years and the basics are always needed – coping with trauma, obtaining information, fighting for rights, accessing services, and, sadly, demand still outstrips supply.**

By becoming a Friend of BAS you will be supporting a local charity which does very valuable work in a field where demand is growing, a charity that is responsive to the needs of people affected by autism, a charity that can only continue with its work with support from across the community.
